

# Burra Golf Club Inc.

## Regulations

### 1. Members

#### 1 Types of Member

1.1.1 Members will be divided into the following groups. Variations to rights & subscription are set out for each group.

#### 1.2 Full Members

1.2.1 Full Members have full playing rights and are entitled to compete in all club competitions and are eligible for special trophies & events. The annual subscription for full members will be 100% of the annual subscription set by the committee. Full members will also pay affiliation fees, levies & costs incurred by the club on a per member basis on the member's behalf.

#### 1.3 Country Members

1.3.1 Members living 80 kilometres or more from the Burra Post Office may apply for Country Membership. Country Members will have the same rights as full members. The annual subscription for country members will be 70% of the annual subscription set by the committee for full members. Country members will also pay affiliation fees, levies & costs incurred by the club on a per member basis on the member's behalf.

#### 1.4 Winter Members

1.4.1 Winter Members will have full playing rights from April 1 until September. Winter members will be entitled to compete in all club competitions and are eligible for special trophies & events between those dates. The annual subscription for winter members will be 65% of the annual subscription set by the committee for full members. Winter members will also pay affiliation fees, levies & costs incurred by the club on a per member basis on the member's behalf.

#### 1.5 Summer Members

1.5.1 Summer Members have full playing rights from October 1 until March 21. Summer members are entitled to compete in all club competitions and are eligible for special trophies & events between those dates. The annual subscription for summer members will be 65% of the annual subscription set by the committee for full members. Summer members will also pay affiliation fees, levies & costs incurred by the club on a per member basis on the member's behalf.

#### 1.6 Restricted Members

1.6.1 Restricted Members shall be eligible to play on the course on any day except for times when the course is closed for Men's Competition between 11:30 am & 1:00 pm on Saturdays & for Men's & Women's competition on Tuesday's between 8:00 am & 11:00 am. The annual subscription for restricted members will be 65% of the annual subscription set by the committee for full members. Restricted members will also pay affiliation fees, levies & costs incurred by the club on a per member basis on the member's behalf.

#### 1.7 Junior Members

1.7.1 Junior Members are persons under the age of 18 years. Junior Members have full playing rights and are entitled to compete in all club competitions and are eligible for special trophies & events. The annual subscription for Juniors will be set separately by the committee. Junior members will also pay affiliation fees, levies & costs incurred by the club on a per member basis on the member's behalf.

#### 1.8 Social Members

1.8.1 Social Members have no playing rights. The annual subscription for social members will be set separately by the committee. No affiliation fees, levies or costs will apply.

### 2 Payment of Subscriptions

2.1 Subscriptions are due on April 1 each year.

2.1.1 Members may elect to pay subscriptions in installments provided they elect to do so prior to April 1. Members may elect to pay quarterly or monthly. Quarterly payments will incur a surcharge of 5%. Monthly payments will incur a surcharge of 10%.

- 2.1.2** Annual payments must be paid in full by March 31 each year. Quarterly payments are due on March 1, July 1, October 1 & January 1. Monthly payments must be paid by the 1<sup>st</sup> day of each month.
- 2.2** Please note clause 8 (1.j) of the Club's constitution.
  - 2.2.1** "The Committee may waive all or part of a Member's subscriptions, fees or levies and may agree terms of payment for a Member different from those applicable to other Members if the Committee is satisfied that there are special reasons to do so."
